That on **June 25, 2014**, the Contractor entered into a subcontract in the amount of **\$6,260.00** with the Claimant to **cap parapet wall metal cornice, close windows and cover with siding, cap windows with aluminum capping, close chimney with plywood and modified material, install kitchen windows, and replace broken glass** for and in the improvement, and that on **July 11, 2014**, the Claimant completed all work required to be done by the contract.

3. That the Contractor and Owner are entitled to credits on account thereof for payments to the Claimant in the amount of **\$0.00**, leaving due, unpaid and owing to the Claimant, after allowing all credits, the sum of **\$6,260.00**, for which, with interest, costs and fees, the Claimant claims a lien against the Contractor and the Owner on the land and improvements and on the money or other consideration due or to become due from the Owner under the contract.

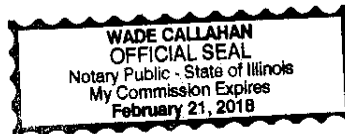
