# AN ORDINANCE APPROVING MODIFICATIONS TO THE PREVIOUSLY APPROVED SITE PLAN TO ALLOW THE CONTINUED USE OF TEMPORARY SIGNS AT 9641-9755 WOODS DRIVE, SKOKIE, ILLINOIS IN AN OR OFFICE RESEARCH DISTRICT

WHEREAS on October 4, 2004, the Mayor and Board of Trustees of the Village of Skokie adopted Village Ordinance Number 04-10-Z-3308 granting site plan approval for the construction and establishment of a 700 unit multi-family residential development at the property legally described as follows:

LOT 2 IN OLD ORCHARD WOODS SUBDIVISION, BEING THAT PART OF THE EAST HALF OF THE SOUTHWEST 1/4 OF SECTION 9, TOWNSHIP 41 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

commonly known as 9641-9755 Woods Drive, Skokie, Illinois in an OR Office Research district (hereinafter "Subject Property"); and

**WHEREAS**, the owner of the Subject Property, Optima Old Orchard Woods-Maple, LLC (hereinafter "Optima"), requested that they be permitted to modify the previously approved site plan to allow the continued use of temporary sales signs displayed both on and off the Subject Property; and

WHEREAS, Condition Number 4 of Village Ordinance Number 04-10-Z-3308 permitted the display of an off-premises sales sign at Golf Road and Woods Drive and another sign on the Subject Property with the provision they be removed by December 31, 2008; and

**WHEREAS**, a recent inspection of the Subject Property revealed the signs are still in place. The signs are 4 feet by 6 feet and approximately 7 to 8 feet in height, which are smaller than the originally approved signs; and

**WHEREAS**, Optima has requested the two signs be kept in place until 2021 to assist in the sale of units in the third building of the development, which was rented during the real estate depression; and

WHEREAS, pursuant to Section 118-8(c) of the Skokie Village Code, the Corporation Counsel, Plan Commission Chairman and Community Development Director reviewed the request and found that (i) the continued use of the temporary sales signs is in substantial compliance with the site plan approval granted on October 4, 2004, (ii) the request does not change the intent of the site plan approval affecting the Subject Property, and (iii) the site plan approval could be amended utilizing the modified review procedure; and

WHEREAS, it was recommended to the Mayor and Board of Trustees that the requested modification be granted; and

WHEREAS, at a public meeting duly held July 21, 2014, the Mayor and Board of Trustees concurred in the aforesaid recommendations and findings of fact of the Corporation Counsel, Plan Commission Chairman and Community Development Director:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Skokie, Cook County, Illinois:

Section 1: That the owner of the Subject Property is hereby granted permission to modify the previously approved site plan to allow the continued use of the two existing temporary sales signs at both Golf Road and Woods Drive and on the Subject Property, commonly known as 9641-9755 Woods Drive, Skokie, Illinois, in an OR Office Research district.

That Condition #4 of Village Ordinance Number 04-10-Z-3308 is hereby Section 2: amended with the new material highlighted in bold and the material to be deleted is highlighted and stricken through.

4. Temporary construction and pPermanent ground and directional signs shall be provided in substantial conformance with the final Village approved Sign Plans types 5, 6, 7 dated June 18, 2004, and Sign Plans - types M, P1 & P-2 dated July 19, 2004. The temporary signs (types 5, 6 and 7) shall be maintained in good condition and removed by December 31, 20082021. Time periods may be extended through the modified review process.

Section 3: That a notice of the approval of this Ordinance incorporating the conditions contained herein shall be executed by the owner of the property in writing and duly recorded with the Cook County Recorder of Deeds Office at the owner's expense.

That this Ordinance shall be in full force and effect from and after its passage, approval and recordation as provided by law.


