MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE is executed as of the 3rd day of September, 2014 by and between THE METROPOLITAN WATER RECLAMATION DISTRICT OF GREATER CHICAGO, a municipal corporation ("Landlord"), and HEARTLAND RECYCLING, L.L.C., an Illinois limited lightly company ("Tenant").

Landlord and Tenant have entered into trat certain Lease Agreement dated August 7, 2014 (the "Lease"), pursuant to which Landlord nas leased to Tenant certain vacant land commonly known as 6400 West 41st Street, Forest View, Illinois, legally described on Exhibit A attached hereto and made a part hereof (the "Leased Premises")

Landlord and Tenant have entered into this Memorandum of Lease to confirm the Lease of the Leased Premises and to provide notice to any interested parties of such Lease and to provide notice of certain terms and provisions thereof.

- 2. <u>Term of Lease</u>. Landlord leases to Tenant and Tenant leases from Landlord the Leased Premises for a term commencing on August 15, 2014 and ending on August 15, 2035. There are no options to extend the Lease term.
- 3. **Easement**. Pursuant to Article 11 of the Lease, Tenant is granted a non-exclusive easement to traverse 41st Street from Cicero Avenue and Canal Bank Road from Harlem Avenue to access the Leased Premises.
