As of December 9, 2013, Leopardo entered into a written contract with TRC under which Leopardo agreed to provide labor, material, superintendence and equipment to perform construction services as general contractor to construct a children's dialysis-hemo center in an existing building on the Real Estate in exchange for payment of the original stipulated sum of \$787,060, subject to allowances and increase for additional or changed work, delays or differing site conditions or encountering of hazardous substances (the "Contract").
- 3. TRC ordered additional and extra work in the amount of \$49,591 so that the final adjusted Contract Price is \$836,651.
- 4. The Contract was entered into by TRC and the original work and extra work was performed by Lec pardo with the knowledge and consent of Owner or Owner's agent. Alternatively, TRC is Owner's agent.
- 5. Leopardo substrutially completed Leopardo's Work under the Contract on May 12, 2014.
- 6.
