- 4. The subject contract was entered into by CONTRACTOR and the labor materials, and services were furnished by CLAIMANT with the full knowledge and consent of OWNER. Alternatively, OWNER authorized or knowingly permitted CONTRACTOR to enter into the subject contract to improve the aforesaid subject real property. Alternatively, OWNER improvingly permitted CLAIMANT to provide labor, materials, and services to improve the aforesaid subject real property.
- 5. On or about July 23, 2014, CLAIMANT substantially completed all work under the subject contract and subsequent extra work.
- 6. OWNER is entitled to total credits of Three Thousand Five Hundred Ninety and 00/100 Dollars (\$3,590.00), leaving due unpaid and owing to CLAIMANT, after allowing such credits, the sum of Three Thousand Five Hundred Ninety and 00/100 Dollars (\$3,590.00), for which, with interest, CLAIMANT claims a lien upon said land and improvement and on the monies
