THIS RELEASE OF REDEVELOPMENT AGREEMENT is executed on or as of the 15th day of September, 2014, by the CITY OF CHICAGO, an Illinois municipal corporation, acting by and through its Department of Planning and Development (the "City").

Resurrection Homes, LLC, an Illinois limite's liability company ("Developer"), and the City entered into that certain Redevelopment Agreem n. - New Homes for Chicago Program (the "Agreement"), dated August 14, 2007, and recorded Nevember 16, 2007 as document number 0732031006 with the Cook County Recorder of Deeds, relating to the City's New Homes for Chicago Program.
