Cumberland Ave., Park Ridge, IL 60068, and any persons claiming to be interested in the premises herein, and states:

1. That on April 28, 2014, Owners owned the following described land in the County of Cook, State of Illinois, to wit:

with Permanent Tax Number 09-35-406-011-0000, commonly known as 837 S. Cumberland Ave., Park Ridge, IL 60068, and Contractor was Owners' general contractor for the improvement thereof.

- 2. That on April 28, 2014, Contractor made an oral subcontract with the claimant, Subcontractor, to provide labor and materials to reinforce the foundation for and in the improvement and that on May 27, 2014, the claimant completed all work required to be done by the contract.
- 3. That Contractor is entitled to no credits on this account leaving due, unpaid, and owing to the claimant, after allowing all credits, the sum of \$6,000.00, for which, with interest, the claimant claims a lien against Contractor and Owners on the land and improvements and on the money or other consideration due or to become due from Owners under the contract.
