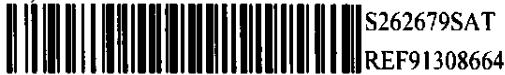

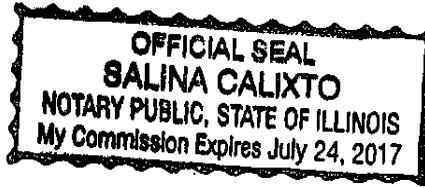

EXHIBIT "A"

LEGAL DESCRIPTION

THE LAND REFERRED TO IN THIS POLICY IS DESCRIBED AS FOLLOWS:

LOT 1 IN CRAIGIE LEA, BEING A RESUBDIVISION OF BLOCK 6 IN GLENCOE IN THE NORTHWEST FRACTIONAL QUARTER OF SECTION 8, TOWNSHIP 42 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, TOGETHER WITH THE EASTERLY 54 FEET OF VACATED LONGWOOD AVENUE LYING WESTERLY OF AND ADJOINING SAID BLOCK 6 IN VILLAGE OF GLENCOE, IN COOK COUNTY, ILLINOIS,

EXCEPTING THAT PART OF LOT 1 DESCRIBED AS FOLLOWS: COMMENCING AT THE INTERSECTION OF THE SOUTHERLY LINE OF LALESIDE TERRACE AND THE WESTERLY LINE OF DELL PLACE, SAID POINT BEING THE NORTHEASTERLY CORNER OF LOT 2 IN SAID CRAIGIE LEA; THENCE SOUTHWESTERLY, ALONG THE WESTERLY LINE OF DELL PLACE, ON AN ASSUMED BEARING OF SOUTH 32 DEGREES, 45 MINUTES, 03 SECONDS WEST, 150.0 FEET TO A POINT THAT IS ALSO 124.71 FEET AT A BEARING SOUTH 57 DEGREES, 14 MINUTES, 57 SECONDS EAST FROM THE NORTHERN MOST POINT OF LOT 1, SUCH POINT BEING THE POINT OF BEGINNING; THENCE CONTINUING SOUTH 32 DEGREES, 45 MINUTES 03 SECONDS WEST, 123.84 FEET, TO A POINT OF CURVE; THENCE SOUTHWESTERLY, ALONG A CURVE, CONVEX SOUTHEASTERLY AND HAVING A RADIUS OF 754.20 FEET AND A CHORD BEARING OF SOUTH 42 DEGREES, 52 MINUTES, 20 SECONDS WEST, AN ARC DISTANCE OF 266.45 FEET TO AN IRON PIPE; THENCE NORTH 83 DEGREES, 52 MINUTES, 07 SECONDS EAST, ALONG THE SOUTHWESTERLY LINE OF SAID LOT 1 A CHORD DISTANCE OF 49.11 FEET; THENCE NORTH 58 DEGREES, 16 MINUTES, 51 SECONDS EAST, 59.29 FEET TO A POINT 6.21 FEET NORTHWESTERLY OF THE BACK OF CURB OF SAID DELL PLACE AS OF OCTOBER 21, 1996; THENCE NORTH 42 DEGREES, 14 MINUTES, 53 SECONDS EAST, 161.17 FEET TO A POINT 0.25 FEET NORTHWESTERLY OF THE POINT OF CURVE IN SAID DELL PLACE; THENCE NORTH 32 DEGREES, 45 MINUTES 03 SECONDS EAST, ALONG A LINE 0.25 FEET NORTHWESTERLY AND PARALLEL WITH THE WESTERLY LINE OF DELL PLACE 123.84 FEET TO THE NORTHERLY LINE OF SAID LOT 1; THENCE SOUTHEASTERLY 0.25 FEET TO THE POINT OF BEGINNING.
