NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Developer hereby declares as follows:

- 1. The foregoing recitals are true and correct and are incorporated herein as if fully set forth hereinafter.
- 2. <u>Exhibit A</u> to the Declaration, containing the Plat and legal description of the Condominium Property submitted to the Declaration, is hereby amended to include Condominium Units 802 and 804. For purposes of clarity, the revised <u>Exhibit A</u>, as attached to and made a part of this Fifth Amendment, contains all the Condominium Property as of the date hereof, and such attachment shall be hereinafter deemed to constitute Exhibit A to the Declaration.
- 3. Exhibit B to the Declaration, containing the percentage of ownership of each Condominium Unit, is bereby amended to include Condominium Units 802 and 804. For purposes of clarity, the revised Exhibit B, as attached to and made a part of this Fifth Amendment, contains a description of each Condominium Unit's undivided percentage of ownership in the Common I lements of the Condominium, and such attachment shall be hereinafter deemed to constitute Exhibit B to the Declaration.
- 4. Exhibit C to the Declaration, containing a legal description of the Future Expansion Property is hereby deleted in its entirety and the attached Exhibit C is substituted in its place.
- 5. Except as otherwise modified herein, the Declaration remains valid and in full force and effect.
- 6. In the event of a conflict or inconsistency between the terms of this Fifth Amendment and the provisions of the Declaration, the provisions of this Fifth Amendment shall control. Capitalized terms in this Fifth Amendment, unless otherwise defined perein, shall have the meaning given to them in the Declaration.
