MEMORANDUM OF EASEMENT AGREEMNET

THIS MEMORANDUM OF EASEMENT AGREEMENT (the "Memorandum of Easement") is made and entered into on or as of this 8th day of September, 2014, by and between THE BELT RAILWAY COMPANY OF CHICAGO, an Illinois corporation, hereinafter referred to as the "Railway Company", and the CITY OF CHICAGO, an Illinois municipality and home rule unit of local government, hereinarter referred to as the "City":

WITNESSETH:

WHEREAS, the City desires to construct, install, maintain, operate, and use a 60-inch, reinforced-concrete sewer pipe under the property and railroad tracks of the Railway Company at and along Austin Avenue in the City of Chicago.

WHEREAS, the Railway Company agrees to grant the City such rights pursuant to the terms and conditions set forth herein.

WHEREAS, the Railway Company and the City have entered into a Sower Pipe Line Easement Agreement, dated September 8, 2014 (the "Easement Agreement"), which grants the City a perpetual non-exclusive easement, subject to the terms and conditions set forth in the Easement Agreement, to construct, install, reconstruct, operate, use, maintain, repair, renew and remove, a 60-inch, reinforced-concrete sewer pipeline, at the location described in Exhibit A, attached hereto and made a part hereof, hereinaster called ("Easement Property") for the sole purpose of a sewer pipeline under the property of the Railway Company.

NOW, THEREFORE,

1. All the terms, conditions, provisions and covenants of the Easement Agreement are incorporated herein by this reference for all purposes as though written out at length herein, and both the Easement Agreement and this Memorandum of Easement shall be deemed to constitute a single instrument or document. This Memorandum of Easement is not intended to amend, modify, supplement, or supersede any of the provisions of the Easement Agreement, and, to the


(1 of 2) is Print showing Easement Area
