THIS SU'SORDINATION AGREEMENT is given this 24TH day of OCTOBER, 2014, by and between QUICKEN LOANS, INC., ISAOA ("New Lender"), and SunTrust Bank ("SunTrust").

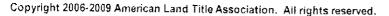
