VINIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Fayment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Securing the Property includes, but is not limited to, entering the Property to make repairs, change locks, replace or board up doors and window, drain water from pipes, eliminate building or other code violations or dangerous conditions and have utilities turned on or off.
