**THE COURT HEREBY ORDERS THAT:**

- 4219 (1) Plaintiff's Motion is granted and Default is entered against Defendant FutureMark as to all Counts of the Verified Complaint for failure to appear or answer or otherwise plead to the Verified Complaint;
- 4001 (2) Judgment is entered in favor of Plaintiff American Precision Services, Inc. and against Defendant FutureMark in the total amount of \$413,886.35 (which includes compensatory damages in the amount of \$406,543.27; attorneys' fees in the amount of \$ 6,645.00 and costs in the amount of \$698.08).
- (3) Post-judgment interest shall accrue at 9% per annum pursuant to 735 ILCS 5/2-1303.
- 9208 (4) This Court finds there is no just reason to delay enforcement or appeal of this order or both.
