- (d) Regulations of HUD Secretary. In many circumstances regulations issued by the Secretary will tin it Lender rights, in the case of payment defaults, to require immediate payment in full and for close if not paid. This Security Instrument does not authorize acceleration or foreclosure if not per art ed by regulations of the Secretary.
- (e) Morigage Not Insured. #### 16. Hazardous Substances
