All materials Claimant provided were of the type, quality and quantity requested and required by Subcontractor and were delivered to the above property for use in the improvements thereon. Claimant last shipped and supplied the material to substantially complete its work on August 9, 2014.
- 4. That with regard to the Outlots/Buldings B and C project, pursuant to an open credit account with Claimant, and from July through August 19, 2014, Subcontractor ordered,

purchased and accepted materials from Claimant for the improvements being constructed on the above property. All materials Claimant provided were of the type, quality and quantity requested and required by Subcontractor and were delivered to the above property for use in the improvements thereon. Claimant last shipped and supplied the material to substantially complete its work on August 19, 2014.

5. That the following amounts are due on said contracts to Claimant after allowing all credits: on the Mariano's project, the sum of Thirty-Four Thousand Six Hundred Two Dollars and Twenty cents (\$34,602.20), plus for the Outlots/Buildings B and C project, the sum of Twenty Thousand Eight Hundred Fifty Four Dollars and Eight Cents (\$20,854.03), for a total of \$55,456.28, which, with interest, costs and expenses the Claimant claims a lien on said land and improvements and on the money or other consideration due or to become due from the Owner against all persons interested.
