

REVOCATION OF POWER OF ATTORNEY

George, O.M.I., as The Catholic Bishop of Chicago, a corporation sole (the "Corporation") created and existing pursuant to an Act of Legislature of the State of Illinois, hereby revoke the appointment of **Roman Szabelski** of the County of Cook, State of Illinois, to act as the Corporation's true and lawful attorney. The designation of **Roman Szabelski** as the legal representative of The Catholic Bishop of Chicago, with power of attorney is expressly recalled. This revocation renders null and void the authority and power of **Roman Szabelski** to do any and all acts to which she was previously empowered and as set forth in the Power of Attorney dated May 30, 2002, and recorded as document number 0020657887 in Cook County and document number 4949492 in Lake County which are attached hereto.

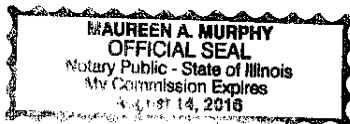




George, as The Catholic Bishop of Chicago, a Corporation Sole created and existing pursuant to an Act of Legislature of the State of Illinois, hereby makes, constitutes, and appoints **Roman Szabelski** of the County of Cook, State of Illinois, as the true and lawful attorney of The Catholic Bishop of Chicago, with authority and power for and in the name of said Corporation for the following purposes and no other:

1. To determine and to execute on behalf of the Corporation all contracts, agreements, assignment or transfers, releases, receipts, consents and other documents which said Attorney may find appropriate to carry out the routine business of Catholic Cemeteries, an agency of the Corporation, provided, however, that said Attorney shall not have the power to receive and convey the real and tangible personal property of the Corporation.

This power of attorney shall be effective until the first to occur of the death of the undersigned or execution of an instrument revoking this power of attorney.
