The Court being fully advised of the premises of this proceeding and having heard the testimony of the City's inspector, finds that:

- 1. The Court has jurisdiction of the parties hereto and the subject matter, which is the premises located at the following address 7404 S. Dorchester Ave., Chicago, Illinois, and legally described as follows:
- LOT 3 AND THE NORTH 1/2 OF LOT 4 IN J.S. SCOVELS ADDITION TO CORNELL, A SUBDIVISION OF THE EAST 1/2 OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF THE NORTHEAST 1/4 OF SECTION 26, TOWNSHIP 38 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

This parcel has a Permanent Index Number of 20-26-226-018.

- 2. Located on the subject property is a TWO-STORY FRAME SINGLE FAMILY BUILDING.
- 3. The Court having heard testimony and evidence finds that the building located on the subject property is dangerous, hazardous, unsafe and beyond reasonable repair under the Unsafe Buildings Statute, 65 ILCS 5/11-31-1 (1996) in that:
 - a) THE BUILDING'S ELECTRICAL SYSTEM HAS EXPOSED WIF INC'.
 - b) THE BUILDING'S ELECTRICAL SYSTEM IS MISSING FIXTURES.
 - c) THE BUILDING'S ELECTRICAL SYSTEM IS STRIPPED AND INOPERABLE.
 - d) THE BUILDING'S FLOOR IS MISSING.
 - e) THE BUILDING'S FLOOR IS WARPED.
 - f) THE BUILDING'S GLAZING SYSTEM IS BROKEN OR MISSING.

- g) THE BUILDING'S HEATING SYSTEM IS MISSING DUCTWORK.
- h) THE BUILDING'S HEATING SYSTEM IS MISSING FURNACE.
- i) THE BUILDING'S HEATING SYSTEM IS STRIPPED AND INOPERABLE.
- j) THE BUILDING'S HEATING SYSTEM IS VANDALIZED.
- THE BUILDING'S JOISTS ARE CRACKED.
- I) THE BUILDING'S MASONRY IS MISSING SIDING.
- m) THE BUILLING'S MASONRY HAS STEP OR STRESS FRACTURES.
- n) THE BUILDINGS MASONRY HAS WASHED OUT MORTAR JOINTS.
- o) THE BUILDING'S PLASTER IS BROKEN OR MISSING.
- p) THE BUILDING'S PLUMBING SYSTEM IS MISSING FIXTURES.
- q) THE BUILDING'S PLUMBING SYSTEM IS STRIPPED AND INOPERABLE.
- r) THE BUILDING'S SASHES ARE BROKEN, MISSING, OR INOPERABLE.
- s) THE BUILDING'S STAIRS HAVE DAMAGED DECKING.
- t) THE BUILDING'S STAIRS HAVE DAMAGED HANDRAIJ.S.
- u) THE BUILDING'S STAIRS ARE DANGEROUS AND HAZAR DOUS.
- v) THE BUILDING'S STAIRS HAVE IMPROPER FOUNDATIONS.
- w) THE BUILDING'S STAIRS HAVE IMPROPER HANDRAIL HEIGHT.
- 4. Demolition of the subject property, as a whole, is the least restrictive alternative available to effectively abate the conditions now existing there.
- A. The Court finds that the City has met its obligations under Section 21-410 of the Property Tax Code and that property tax certificate holders are subject, inter alia, to Sections 21-95, 21-

	100, 21-105, and 22-35 of the Property Tax code. The property tax certificate holder, is dismissed as a party defendant.
В.	Defendants UNKNOWN OWNERS and NONRECORD CLAIMANTS , having been notified by publication, and having failed to appear, answer, or otherwise plead as of the default dates of August 6, 2014 , are in default and all allegations in the complaint are deemed admitted against Defendants in default.
C.	An <u>in rem</u> judgment is entered in favor of Plaintiff City of Chicago and against defendants on Counts I and IV of the City's complaint seeking demolition authority.
D.	Pursuant to Court II of the City's Complaint, Defendant shall pay a fine of with execution to issue.
E. witho	Counts III, V, VI, VII, VIII, and all the remaining counts of the City's Complaint are voluntarily drawn.
F.	Pursuant to the judgment entered above, 65 ILCS 5/11-31-1, and the City's police powers under Article VII of the Illinois Constitution, the City is granted authorization to demolish the building on the subject property, and is entitled to a lien for the costs of demolition, court costs, and other costs enumerated by statute, and/or other statutory remedies.
G.	The authority granted in Paragraph F above shall be effective 60 10/15/14
H.	Defendant owners are ordered to keep the property secule until it is demolished.
1.	The City's performance under the Order will result in a statutor, in rem lien that attaches only to the subject parcel of real estate. If the City seeks a personal judgment against any individual party to this action, it will proceed by separate motion directed to that party.
J.	Defendants with either possession or control of the subject property shall immediately remove any and all persons occupying the subject property and all personal property from said premises <u>instanter</u> so that said premises will be completely vacant and free of personal property before demolition is commenced. The City's Department of Human Services is authorized to assist in the relocation of any tenants.
K.	Pursuant to Illinois Supreme Court Rule 304(a), this is a final and appealable order and the Court finds that there is no just reason for delaying the enforcement or appeal of this order.
L.	The Court reserves jurisdiction of this cause to enforce the terms of this Order, for the purpose of ascertaining demolition costs for entry of money judgments against the
