- 3. On or about March 6, 2013, the Association served Owner with a Thirty-Day Demand and Notice pursuant to which the Association demanded that the Owner pay \$11,294.92 in unpaid assessments, costs, expenses, late fees, and attorney fees.
- 4. As of December 31, 2014, the Owner has failed to pay the Association any amounts as demanded in the Thirty-Day Demand and Notice.
- 5. As of December 31, 2014, after allowing all credits, the Owner owes \$16,749.12 to the Association for unpaid assessments, costs, expenses, late fees, and attorney fees. Said sum will increase as additional assessments, costs, expenses, late fees, and attorney fees may accrue.
- 6. The Association hereby claims a lien against the Real Estate and Owner in the amount of \$16,749.12.
