**CONSENT JUDGEMENT FOR ATTORNEYS'
FEES AND COSTS AGAINST PATRICIA RABIELA**

This matter came before the Court on the Complaint of Anderson & Boback ("Anderson") pursuant to for a Judgement for Attorney's Fees and Costs in favor of Anderson and against PATRICIA RABIELA, the client. The Court has reviewed Anderson & Boback's Complaint, the signed retainer agreement between Anderson & Boback and PATRICIA RABIELA, and being fully advised of the premises makes the following findings and orders:

The parties agree and the Court finds that:

1. Anderson & Boback represented PATRICIA RABIELA in the divorce proceedings as alleged in their Complaint.
2. The attorneys' fees and costs charged by Anderson & Boback and incurred by PATRICIA RABIELA were reasonable and necessary.
3. PATRICIA RABIELA has acknowledged receipt and review of the Complaint and bills detailing the services performed and the charges incurred on a regular monthly basis.
4. PATRICIA RABIELA has acknowledged being advised of, understanding, and being aware of, her right:
 - a. To a hearing at which the reasonableness of the amount of the attorneys' fees and costs that he is being charged by Anderson & Boback would be


determined.

- b. To a hearing on the Petition filed by Anderson & Boback for entry of a Judgment against her for attorneys' fees and costs.
 - c. To be represented by an independent counsel other than Anderson & Boback, at such a hearing; and
 - d. To be present and to participate in the presentation and hearing on the Complaint for Attorney Fees against her and in favor of Anderson & Boback.
5. PATRICIA RABIELA has voluntarily and expressly waived her rights, agreed to the terms of this Consent Judgment, and further agreed to the entry of this Consent Judgment in favor of Anderson & Boback and against PATRICIA RABIELA.

IT IS THEREFORE HEREBY ORDERED:

- A. PATRICIA RABIELA is ordered to pay to Anderson & Boback, the sum of Eight Thousand Four Hundred Twenty-Two Dollars (\$8,422.00) plus costs of Two-Hundred Eighty Nine Dollars (\$289.00) for a total Judgment of Eight Thousand Seven Hundred Thirty One (\$8,711.00)
- B. PATRICIA RABIELA shall pay to Anderson & Boback no less than \$100.00 per month beginning February 1, 2009 until such time as the Judgment is paid in full.
- C. This is a final Judgment and there is no just reason for delaying either enforcement or appeal or both.
