This document is recorded for the purpose of amending the Declaration for Arlington Crossings Townhomes and Provisions Relating to Easements Affecting Portions of The Development Area Other Than The Premises (hereafter the "Declaration") for the Arlington Crossings Townhome Owners Association (hereafter the "Association"), which Declaration was recorded on December 17, 2010 as Document Number 103514/041 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit A, which is attached hereto and made a part hereof

This Amendment is adopted pursuant to the provisions of Article Ten, Section 10.02 of the Declaration. Said section provides that the Declaration may be amended, abolished, modified, enlarged, or otherwise changed in whole or in part by the affirmative vote of Voting Members representing at least Seventy-Five Percent of the total votes or by an instrument consented to, in writing, executed by Owners of at least Seventy-Five Percent of the Lo.s.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook

WHEREAS, the Board and the Owners desire to amend the Declaration in order to provide for the orderly operation of the Property; and

WHEREAS, the following amendment has been approved by the affirmative vote of Voting Members representing at least Seventy-Five Percent of the total votes, which approvals are attached hereto and made a part hereof; and

WHEREAS, the Secretary of the Board has attested to said Owner approval by execution of Exhibit B attached hereto and made a part hereof; and

NOW, THEREFORE, the Declaration for the Arlington Crossings Townhome Owners Association is hereby amended in accordance with the text which follows (additions in text are indicated by a couble underline; deletions by strike-outs):


Section 2.45 of the Declaration is hereby amended as follows:

- 2.15 <u>LEASE OF HOME</u>: Subject to the provisions of Section 9.02, aAn Owner shall have the right to lease all (and not less than all) of his Home subject to the following provisions:
- (a) No Home shall be leased for less than six (6) months or for hotel or transient purposes; and
- (b) Any lease shall be rewriting and shall provide that such lease shall be subject to the terms of this Declaration and that any failure of the lessee to comply with the terms of this Declaration shall be a default under the lease. A lessee shall be bound by the provisions hereof regardless of whether the lease specifically refers to this Declaration.
- (b) The rental or leasing of Homes is limited to a total of ten percent (10%) of the Homes. All leases shall be in writing and shall provide that such lease shall be subject to the terms of this Declaration and any failure of the lessee to comply with the terms of this Declaration shall be a default under the lease. A lessee shall be lound by the provisions hereof regardless of whether the lease specifically refers to this Declaration. All tenants shall acknowledge in writing that they have received copies of the Rules and Regulations of the Association and a copy of the written receipt shall be submitted to the Board.
- (c) Each Owner who leases his Home shall be required to furnish the Association with a copy of the lease and shall promptly notify the Association of any change in status of the lease. The Association shall maintain a record of such information with respect to all leased Homes.
- (d) Any Owner desiring to lease out their Home must apply to the Board prior to entering into a lease agreement and their name will be added to a waiting list to be maintained by the Board or the managing agent.
- (e) Whenever ten percent (10%) or more of the Homes at the Association are being leased, no other Homes may be leased except as set forth below in subparagraphs (g) and (h).

- Association are being leased out the name on the waiting list for the longest period of time shall have the first opportunity to lease their Home. That Owner will be given thirty (30) days to indicate whether they intend to lease out their Home. That Owner will then have an additional thirty (30) days to present a signed lease to the Board, otherwise the right to lease shall pass to the next Owner on the waiting list. The Board shall promptly review the proposed lease agreement in order to verify that it complies with the standards as set forth herein. All leases must be for at least one (1) year. Further, all leases shall provide that any failure of the lessee to comply with the terms of this Declaration shall be a default under the lease. The Owner making any such lease shall not be relieved thereby from any of his obligations under the Declaration.
- difficulties, the Board may, but is not required to, grant permission to an Owner to lease his Home to a specified lease for a period of one (1) year on such reasonable terms as the Board may establish. Such permission may be granted by the Board only upon written application by the Owner to the Board giving the reasons the Owner wishes to be considered for a hardship. The Board shall respond to each application in writing within thirty (30) days of the submission thereof. All requests for extension of the original lease must also be submitted to the Board in the same manner as set forth for the original application. The Board has sole and complete discretion to approve or disapprove any Owner's application for a lease or extension of a lease. The Board's decision shall be final and regulations governing the Association.
- (h) Occupancy of a Home by a blood relative of an Owner is permitted, and shall not constitute a lease as defined under this Amendment, even if there is no written memorandum or agreement executed between the parties. "Blood Relative" shall be defined as parents, children (whether natural or adopted), grandparents grandchildren, siblings, and the spouse of the Owner.
- (i) Owners must notify prospective tenants that the Association is a Crime Free Community. Owners must obtain a criminal background check or the prospective tenant and every person moving into a Home, as well as provide a copy to the Board of Directors, no less than thirty (30) days prior to occupancy of the Home. Owners must submit proof to the management company that this was done prior to the tenant moving into the Home. Discrimination on the basis of age, race, color, creed, national origin or sex is not allowed.
- ever been convicted of any violent criminal activity b) been convicted of a drug-related criminal activity within the last five (5) years or been convicted of any form of aggravated sexual assault or been adjudicated a registered sexual offender. "Violent criminal activity" is defined as any felonious criminal activity that has as one of its elements the use, attempted use, or threatened use of physical force against the person or property of another. "Drug-related criminal activity" is defined as the illegal manufacture, sale, distribution, or use, or possession with intent to manufacture, sell, distribute, or use, of a controlled substance (as defined in Section 102 of the Controlled Substances Act [21 U.S.C. 802]).

- (1) Any Home being leased out in violation of this Amendment or any Owner and/or tenant found to be in violation of the Rules and Regulations adopted by the Board of Directors may be subject to a flat or daily fine to be determined by the Board of Directors upon notice and an opportunity to be heard.
- (m) In addition to the authority to levy fines against the Owner for violation of this Amendment or any other provision of the Declaration, By-Laws or Rules and Regulations, the Board shall have all rights and remedies, including but not limited to the right to maintain an action for possession against the Owner and/or their tenant, under 735 ILCS 5/9-111, an action for injunctive and outer equitable relief, or an action at law for damages.
- (n) Any action brought on behalf of the Association and/or the Board of Directors to enforce this Amendment shall subject the Owner to the payment of all costs and attorneys' fees at the time they are incurred by the Association.
- (o) All unpaid charges as a result of the foregoing shall be deemed to be a lien against the Home and collectible as any cher unpaid regular or special assessment, including late fees and interest on the unpaid balance.
- (p) The Board of Directors of the Association shall have the right to lease any Association owned Homes, or any Home which the Association has possession of pursuant to any court order, and said Homes shall not be subject to this Amendment.

This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.

Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.


