If there is a deficiency of Funds held in escrow, as defined under RFSPA, Lender shall notify Borrower as required by RESPA, and Borrower shall pay to Lender the amount 1 ecessary to make up the deficiency in accordance with RESPA, but in no more than 12 monthly payments.
