## LIMITED COMMON ELEMENT PARKING SPACE TRANSFER AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP FOR 933 VAN BUREN CONDOMINIUM

This document is recorded for the purpose of amending the Declaration of Condominium Ownership (hereafter the "Declaration") for 933 Van Buren Condominium (hereafter the "Association"), which Declaration was recorded on December 2, 2002, as Document No. 0021323775 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Fahibit "A", which is attached hereto and made a part thereof.

This amendment is adopted pursuant to the provisions of Article III, Section 3.20 of the aforesaid Declaration and Section 26 of the Illinois Condominium Property Act (the "Act"). The Declaration provides that an Owner of a Unit may assign, to another Owner of a Unit, the Parking Space (limited common element) appurtenant to the Unit Ownership, subject to the prior written consent of the holder of a first mortgage upon the Unit Ownership, upon the recording of an amendment to the Declaration in accordance with Section 26 of the Act Section 26 of the Act provides that each transfer of limited common elements shall be made by an amendment to the Declaration executed by all unit owners who are parties to the transfer and consented to by all other unit owners who have any right to use the limited common elements affected. Section 26 further provides that the amendment shall contain a certificate showing that a copy of the arrendment has been delivered to the Board of Managers of the Association, and shall contain a statement from the parties involved in the transfer which sets forth any change in the parties' proportionate shares of the common elements. No transfer shall become effective until the amendment has been recorded in the Office of the Recorder of Deeds of Cook County, Illinois.

### **RECITALS**

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Act; and

NOW TEFREFORE, the Declaration of Condominium Ownership for 933 Van Buren Condominium is hereby amended in accordance with the text which follows:

- 1. Parking Space 312, as shown on Exhibit A to the Declaration, is hereby transferred from the Owner of Unit 702 in the Association to the Owner of Unit 516 in the Association, and thereupon the Owner of Unit 516 shall have his Unit Ownership include as a right and benefit appurtenant thereto, a grant of a perpetual and exclusive use of said Parking Space.
- 2. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
