# AN ORDINANCE CLOSING OUT NORTHFIELD SPECIAL SERVICE AREA NUMBER 08-1

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Northfield, Cook County, Illinois, as follows:

### **SECTION:** The President and Board of Trustees find as follows:

- A. That Northfield Special Service Area Number 08-1 (hereinafter "Special Service Area Number 08-1") was established by Northfield Ordinance No. 08-1384, adopted June 17, 2008, (the "Establishing Ordinance), and recorded on June 24, 2008, as document number 0817618080, with the Cook County Recorder's Office.
- B. That all public improvements/special services, as contemplated by Special Service Area Number 08-1, have been completed/provided.
- C. That all expenses and costs have been paid in full relative to Special Service Area Number 08-1.
- D. That there are no outstanding bonds in relation to Special Service Area Number 08-1.
- E. That there is no longer any tax levy in effect relative to Special Service Area Number 08-1.
- F. That a review of the Village of Northfield's (the "Village") account relative to Special Service Area Number 08-1 reveals that there are no excess funds in said account.

SECTION 2: In light of the findings set forth in Section 1 above, Special Service Area Number 08-1 is hereby declared completed and closed.
