  - A. Prior to the Modification Effective Date as set forth in Section 3 below, if Lender determines that any of my representations in Section 1 above are no longer true and correct, the Loan Documents will not be modified and this Agreement will terminate.   - B. As of the Modification Effective Date, the new principal balance of my Note is \$204,697.30 (the "New Principal Balance"). In servicing your loan, the Bank may have incurred third-party feet or charges that were not included in the terms of this Agreement. If so, these fees and charges will appear on your monthly statement under "Fees and Charges." These fees and charges will not accrue interest or late fees. You may ray these fees and charges at any time.
