All shares of stock or other evidence of ownership of any part of any of the collateral described in this Exhibit B that is owned by Debtor in common with others, including all water stock relating to any of he collateral described in this Exhibit B, if any, and all documents or rights of membership in any owners' or members' association or similar group having responsibility for managing or operating any of the collateral described in this Exhibit B;
- (n) <u>Tax Credits</u>. All refunds, rebates or credits in connection with the reduction of taxes as a result of tax certiorari or any applications or proceedings for deduction:
- (o) <u>Intellectual Property</u>. All trade names, trademarks, service marks, logos, copyrights, goodwill, books and records (including, but not limited to recorded data of any kind or nature, regardless of the medium of recording, including software, writings, plans, specifications and schematics) and other general intangibles specific to or used in connection with the operation of the collateral described in this Exhibit B;
- (p) <u>Proceeds</u>. All proceeds, whether cash, promissory notes, contract rights or otherwise, of the sale or other disposition of all or any part of the estate of Debtor upon the Land now or hereafter existing thereon;
- (q) <u>Sale Contracts</u>. All sales contracts, escrow agreements and broker's agreements concerning the sale of any of the collateral described in this <u>Exhibit B</u>; and
- (r) Other. All and singular the rights, members and appurtenances whatsoever, in any way belonging, relating or appertaining to any of the collateral described in this Exhibit B or which hereafter shall in any way belong, relate or be appurtenant thereto, whether now owned or hereafter acquired by Debtor.
