MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:


The maturity date of the loan is hereby extended to May 5, 2015. All other terms and conditions of the loan documents shall remain in full force and effect.

Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.


