
SUBORDINATION AGREEMENT





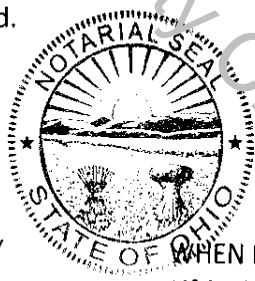
