MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

The definition of "Note" set forth in the Mortgage is hereby amended and restated in its entirely as follows: The word "Note" means individually and collectively, (i) that certain Promissory Note dated February 26, 2015 in the original principal amount of \$730,045.00 executed by Borrower payable to the order of Lender, (ii) that certain Promissory Note dated October 5, 2014 in the original principal amount of \$45,800.00 executed by Borrower payable to the order of Lender, (iii) that certain Promissory Note dated April 15, 2014 in the original principal amount of \$278,147.07 executed by Borrower, payable to the order of Lender, (iv) that certain Promissory Note dated April 5, 2011 in the original principal amount of \$340,893.41 executed by Borrower, payable to the order of Lender, (v) that certain Promissory Note dated September 27, 2010 in the original principal amount of \$358,845.41 executed by Borrower payable to the order of Lender, and (vi) that certain Promissory Note dated April 29, 2003 in the original principal amount of \$90,000.00 executed by Borrower payable to the order of Lender, all as amended, supplemented, modified or replaced from time to time

The paragraph titled "Maximum Lien/Maximum Indebtedness" set forth in the Mortgage secures the entire principal amount of the Loans, interest accrued thereon and all other Obligations. Under no circumstances, however, shall the aggregate principal indebtedness exceed an amount equal to two (2) times the original principal amount of the Notes, together with moneys advanced by the Mortgagee to protect and preserve the lien of this Mortgage..

CONTINUING VALIDITY. Except as expressly readified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. EACH OF GRANTOR AND, BY ITS ACCEPTANCE HEREOF, LENDER HERESY EXPRESSLY AND UNCONDITIONALLY WAIVES AND RELINQUISHES: ANY RIGHT TO TRIAL BY JURY IN ANY ACTION OR PROCEEDING (i) TO ENFORCE OR DEFEND ANY RIGHTS UNDER OR IN CONNECTION WITH THIS AGREEMENT OR ANY AMENDMENT, INSTRUMENT, DOCUMENT OR AGREEMENT DELIVERED OR WHICH MAY BE DELIVERED RELATED TO THIS AGREEMENT OR (ii) ARISING FROM ANY DISPUTE OR CONTROVERSY IN CONNECTION WITH, IN FURTHERANCE OF, OR RELATED TO THIS AGREEMENT OR ANY AMENDMENT, INSTRUMENT, DOCUMENT OR AGREEMENT RELATED THERETO, AND AGREES THAT ANY SUCH ACTION OR PROCEEDING SHALL BE TRIED BEFORE A JUDGE AND NOT A JURY.
