"NOTICE TO THE INDIVIDUAL SIGNING THE ILLINOIS STATUTORY SHORT FORM POWER OF ATTORNEY FOR PROPERTY.

The purpose of this Power of Attorney is to give your designated "agent" broad powers to handle your property, which may include the power to pledge, sell, or dispose of any of your real or personal property, even without your consent or any advance notice to you.
