10. Mortgage Insurance. If Lender required Mortgage Insurance as a condition of making the Loan, Borrower shall pay the premiums required to maintain the Mortgage Insurance in effect. again becomes available, is obtained, and Lender requires separately designated payments toward the premiums for Mortgage Insurance.
