2. Governing Law; Construction. This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois, without giving effect to principles of conflicts of law.
3. Amendments. This Agreement may not be modified or terminated orally or in any manner other than by an agreement in writing signed by all the parties hereto or their respective successors in interest.
4. Counterparts. This Agreement may be executed in any number of counterparts, each of which shall constitute an original, but all of which, taken together, shall constitute but one and the same instrument.
5. Binding Effect. This Agreement is binding upon, and shall inure to the benefit of, the parties hereto and each of their respective successors and permitted assigns, if any.


