Authority to Perform. If Mortgagor fails to perform any duty or any of the covenants contained in this Security Instrument, Lender may, without notice, perform or cause them to be performed. Mortgagor agrees that Lender may pay any amount necessary for performance. However, unless Borrower is in default or this addendum will not permit it, Borrower has the option to convert their Forne Equity Line to the rate and terms of a Fixed Equity Loan. Certain condition must be met prior to exercising the Option to Convert. Those conditions are.
