Lender's right to disapprove such policies, shall include a standard mortgage clause, and shall name Lender as mortgagee and/or as an additional loss payee. - 8. Borrower's Loan Application. Before each Change Date, the Note Holder will calculate my new interest rate by adding TWO AND 750/1000 percentage points (2.750%) to the Current Index. The Note Holder will then round the result of this addition to the nearest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.

The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that I am expected to owe at the Change Data in full on the maturity date at my new interest rate in substantially equal payments. The exult of this calculation will be the new amount of my monthly payment.

(D) Limits on Interest Rate Changes

The hit last rate I am required to pay at the first Change Date will not be greater than 5.500% of less than 2.750%. Thereafter, my interest rate will never be increased or decreased on any single Change Date by more than two percentage points (2.0%) from the rate of interest in lave been paying for the preceding 12 months.
