MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated February 26, 2015, is made and executed between CHESTER J MIKUCKI AND ROSEMARIE MIKUCKI, HIS WIFE, whose address is 4916 N. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
