Depter's actions can include, but are not limited to: (a) paying any sums secured by a lien which has priority over this Security Instrument; (b) appearing in court; and (c) paying reasonable attorreys' fees to protect its interest in the Property and/or rights under this Security Instrument, including its secured position in a bankruptcy proceeding. Securing the Property includes, but is not included to, entering the Property to make repairs, change locks, replace or board up doors and win lows, drain water from pipes, eliminate building or other code violations or dangerous conditions, and have utilities turned on or off. 
