### SPECIAL AND LIMITED POWER OF ATTORNEY FROM *NOVATO TERRY LLC* IN FAVOR OF *TRIMONT REAL ESTATE ADVISORS, INC.*

THIS POWER C. ATTORNEY is given by Novato LLC, a Delaware limited liability company, with its principal place of business at 1290 Avenue of the Americas, Suite 914, New York, NY 10104 ("Novato Terry").

#### KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, Novato Terry is the owner of that certain property described on Exhibit "A" attached hereto and incorporated herein ty reference (the "Property"); and

WHEREAS, the Property is currently serviced and administered by TriMont Real Estate Advisors, Inc., a Georgia corporation ("TriMont") under that certain Servicing Agreement dated as of March 1, 2011 (the "Servicing Agreement"); and

WHEREAS, this Power of Attorney is being made and delivered under, and shall be utilized in furtherance of, the terms and conditions of the Servicing Agreement, and Novato Terry avers that any person may rely on the authorities and powers granted hereunder and any actions of the Attorneys taken pursuant to such authorities and powers as the valid, binding and enforceable actions of Novato Terry without further reference to or production of the Servicing Agreement; and

WHEREAS, Novato Terry is desirous of entering into this Special and Limited Power of Attorney (this "Power of Attorney") to appoint TriMont and any officer or agent thereof, with full power of substitution, as its true and lawful attorney-in-fact with full power and authority to take any action, exercise any and all rights and remedies under the Loan Documents and to execute or endorse any and all documents and instruments in furtherance of the purposes and objectives described herein.

NOW, THEREFORE, Novato Terry, acting through its duly authorized officer, does hereby:

1. constitute and appoint each authorized officer and agent (which are referred to collectively as "Attorneys" and individually as "Attorney") of TriMont, individually, including, without limitation, Matt Stewart, Senior Vice President and Mitchell Hunter, Senior Vice President, as a true and lawful attorney for Novato Terry (but only for the purposes set

forth herein);

- 2. for and in the name and stead of Novato Terry authorize and empower each such Attorney:
- a. to institute the sale, conveyance, assignment, transfer or exchange of the Property;
- b. to stabilize, preserve, manage, maintain, sell, assign, transfer, convey, exchange, pledge, hypothecate, rent, lease or otherwise dispose of all or any part of any Property; and to endorse, execute, seal, acknowledge, deliver, file and/or record (including with the argropriate public officials) any deed of the Property and any mortgage or any other security instrument for the pledge of the Property; and to endorse, negotiate, deliver and deposit any check. draft, money order or other form of payment instrument payable to Novato Terry and tendered as payment on or proceeds from the Property;
- c. to take or cause to be taken through its attorneys, agents and/or representatives such other and further acts as the Attorney may deem necessary or prudent to protect and/or further the interests of Novato Terry with respect to the Property, including without limitation the initiation, raintenance, prosecution, defense and/or termination of any legal, statutory, bankruptcy and/or administrative proceedings arising out of or related to the Property; and to institute the sale, conveyance, assignment, transfer or exchange of any legal actions or judgments related to the Property;
- 3. further authorize and empower each such Attorney, for and in the name and stead of Novato Terry, to:
- a. file and record this Special and Limited Power of Attorney with the appropriate public officials;
- b. appoint and name such substitute attorneys vato all authority and powers hereunder, provided that such substitute attorneys are duly elected and qualified officers of TriMont; and
- c. otherwise carry out any of the other powers expressly or by implication granted in this Power of Attorney.

Novato Terry covenants and grants to the Attorneys full authority and power to execute any documents and instruments and to do and perform any act that is necessary or appropriate to effect the intent and purposes of the foregoing authority and powers hereunder. Novato Terry further ratifies and confirms each act that the Attorneys shall lawfully do or cause to be done in accordance with the authority and powers granted hereunder. The foregoing authority and powers shall not be deemed breached by reason of any action or omission of any Attorneys appointed hereunder. Novato Terry covenants and agrees that, from time to time at the request of TriMont, Novato Terry shall execute instruments confirming all of the foregoing authority and powers of any Attorneys. This Power of Attorney is unconditional and irrevocable by Novato Terry.
