



You and each of you are hereby notified that the Village of South Barrington, County of Cook, is about to annex the territory hereinafter described pursuant to the provisions of Article 7, Division 1 of the Illinois Municipal Code (65 ILCS 5/7-1-1, *et seq.*; 65 ILCS 5/7-1-13). The Village President and Board of Trustees of the Village of South Barrington intend to consider the passage of an ordinance authorizing the annexation of territory at a meeting to be held on April 9, 2015, at 7:30 p.m., in the William R. Rose Hall of the South Barrington Village Hall, 30 South Barrington Road, South Barrington, Illinois. The real estate is described as follows:
