### AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR NUMPORT CONDOMINIUM TO TRANSFER A GARAGE RIGHT

WHEREAS Article II, Section 2.14 (Lease or Transfer of Garage Rights) of the Declaration permits the sale and transfer of garage rights between unit owners provided it is with the written consent of the first mortgagee, if any, and

WHEREAS First Party desires to transfer and assign her garage right no. 63 from Unit 1605-N to Unit 2106-N to Second Party and;

WHEREAS, First Party has placed no mortgage on said garage rights; and

NOW THEREFORE, in consideration of ten dollars and other good and valuable consideration in hand paid, IT IS HEREBY AGREED AS FOLLOWS:

- 1. First Party does hereby transfer and assign their right, title, and interest in the non-exclusive garage right no. 63, a limited common element, previously acquired by her when she acquired Unit 1605-N to the Second Party, owners of Unit 2106-N who shall have the right to park one vehicle in the garage comprising a part of the Newport Condominium.
- 2. Immediately upon the recording of this instrument, the aforesaid non-exclusive garage right no. 63 shall henceforth be considered and treated appurtenant to and shall run with the title to unit 2106-N in the Newport Condominium.
