SUBORDINATION AGREEMENT





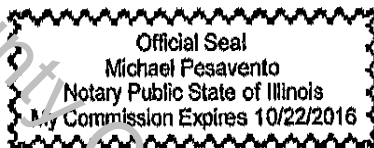
