Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

right to hold the policies and renewal certificates. If Lender requires, Borrower shall promptly give to Lender all receipts of paid premiums and renewal notices. If Borrower obtains any form of insurance coverage, not otherwise required by Lender, for damage to, or destruction of, the Property, such policy shall include a standard mortgage clause and shall name Lender as mortgagee and/or as an additional loss

building or other code violations or dangerous conditions, and have utilities turned on or off.
