

THIS MEMORANDUM OF LEASE, made as of May 22, 2015, by and between 1634 W CHICAGO LLC, an Illinois Limited Liability Company "Lessor", and Carbon on Chicago LLC, an Illinois Limited Liability Company, hereinafter called "Lessee."

WITNESSETH, this MEMORANDUM OF LEASE is executed by and between Lessor and Lessee to memorialize the agreement between them and the rights, duties and obligations of each appertaining thereto.
