That upon confirmation herein and upon request by the successful bidder, or its assigns, and provided that all required payments have been made pursuant to Section 15-1509(a) of the Illinois Mortgage Foreclosure Law (S.H.A. 735 ILCS 5/15-1509(a)) the Selling Officer shall execute and de'ty: to the successful bidder, a deed sufficient to convey title.

That upon request by the successful bidder, including any insurers, investors, and agents of Plaintiff is entitled to and shall have possession of the premises as of a date 30 days after entry of this Order, without further Order of Court, as provided in 735 ILCS 5/15-1701.

IT IS FURTHER ORDERED:

That the successful bidder, or its assigns, is entitled to and shall have immediate possession of the mortgaged real estate, without further Order of Court, as provided in Section 15-1701 of the Illinois Mortgage Foreclosure Law (S.H.A. 735 ILCS 5/15-1701), and;

That in the event possession is so withheld, the Sheriff of Cook Courty is directed to evict and dispossess Grace Laundromat, Inc. d/b/a JR Coin Laundry, Eul Ki Gb and Yoon Hee Oh from the mortgaged real estate commonly known as 5527-5531 West North Avenue, Chicago, IL 60639, without further Order of Court.

No occupants other than the individuals named in this Order of Possession may be evicted without a Supplemental Order of Possession or an Order from the Forcible Entry and Detainer Court.

That the Deed to be issued hereunder is a transaction that is exempt from all transfer taxes, either state or local, and the County Recorder of Deeds is ordered to permit immediate recordation of the Deed issued hereunder without affixing any transfer stamps.
