- 4. That Claimant diligently worked to perform the work required under the subcontract between Claimant and Contractor, and on March 17, 2015, the Claimant completed all work, with total charges of \$6,896.75 incurred therefor.
- 5. That Claimant is entitled to no credits on the owed \$6,896.75, which sum has been demanded from Contractor but has not been paid to Claimant. Therefore as of the date hereof, there is due, unpaid, and owing to Claimant, after allowing all credits, the principal sum of SIX THOUSAND EIGHT HUNDRED AND NINETY-SIX AND 75/100 DOLLARS (\$6,896.75), for which sum, with interest, the Claimant claims a lien against the Contractor and the Owner on the land and improvements and on the money or other consideration due or to become due from the Owner under the contract.
