



#### (B) The Index

Beginning with the first Change Date, my adjustable interest rate will be based on an index. The "Index" is the average of interbank offered rates for one-year U.S. dollar lei ominated deposits in the London market ("LIBOR"), as published in <a href="The Wall Street Journal">The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index."</a>
