LEGAL DESCRIPTION

PARCEL 1

LOT 2 IN BLOCK "A" IN ROBERT'S HOMESTEAD ADDITION TO JEFFERSON; ALSO LOTS 23 TO 29, BOTH INCLUSIVE, IN STEVER'S SUBDIVISION OF JEFFERSON PARK, ALL IN THE NORTHWEST ¼ OF SECTION 16, TOWNSHIP 40 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN (EXCEPT FROM SAID PREMISES THAT PORTION THEREOF DESCRIBED AS FOLLOWS:
