IT IS HEREBY ORDERED THAT:

- The judgment(s) hereby entered on the date(s) of 1/15/02 in the total amount(s) of \$ 1000.00 plus \$60.00 in court costs against defendant(s) Primo Nevarez shall stand as final judgment(s) and that leave for enforcement on said judgment(s) is granted Plaintiff, CITY OF CHICAGO. - The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction, including the adjudication of contempt proceedings if the permanent injunction is violated which could result in the imposition of a fine and/or incarceration.
