Beginning with the first Change Date, my interest rate will be based or an Index. The "Index" is the weekly average yield on United States Treasury securities adjusted to a constant maturity of one year, as made available by the Federal Reserve Board. The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index."

If the Index is no longer available, the Note Holder will choose a new index which is based upon comparable information. The Note Holder will give me notice of this choice.

### (C)Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding TWO and THREE/FOURTHS percentage points (2.750%) to the Current Index.
