THIS MORTGAGE SECURES FUTURE OBLIGATIONS AND FUY ANCES PURSUANT TO 205 ILCS 5/5D. Mortgagee has granted to Borrower a home equity line of credit, providing for a Maximum Credit Limit (that is, a maximum principal amount of indebtedness) of One Hundred Nine (housand Dollars And Zero Cents
