- Pursuant to Section 765 ILCS 605/16 of the Illinois Condominium Property Act, Owner desires to terminate all of the easements, restrictions and covenants, contained in the Declaration hereby removes the Property from the Illinois Condom nium Act to create one parcel of land consisting of a building with 3 residential anartments and a corresponding parking lot.
