The dedications herein provided for are made upon the express condition that within 180 days after the passage of this ordinance, the titleholder: 969 Land LLC, an Illinois Limited Liability Company shall deposit in the City Treasury of the City of Chicago, a sum sufficient to defray the costs of constructing the new public alleys herein dedicated, in accordance with current Chicago Department of Transportation Construction Guidelines for construction of public way.

SECTION 4. The subdivision herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, 969 Land LLC, an Illinois Limited Liability Company shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the corresponding full sized plat as approved by the Department of Transportation/Superintendent of Maps and Plats.

SECTION 5. This ordinance and exhibit subdivision plat shall take effect and be in force from and after its recording.


